- Query for condition-based URIs selection capabilities;
- Subscription to the CBUS event package using Conditions based on either of Location information, Presence Information and User Profile information, or a combination of these;
- Evaluation Information retrieval of Location information, Presence Information and User Profile information; and
- Conditions evaluation and re-evaluation.
