4.1. Version 1.0 Functionality

Version 1.0 defines the following functions:

- 1. Lock the M2M device partially or fully
- 2. Unlock the M2M device
- 3. Wipe the M2M device partially or fully
- 4. Report the result of the above operations

4.2. Version 1.0.3 Functionality

This revision adds the optional elements "LWM2MVersion" and "ObjectVersion" to the Object Lock & Wipe.
