## 3. Terminology and Conventions

### 3.1 Conventions

The key words “MUST”, “MUST NOT”, “REQUIRED”, “SHALL”, “SHALL NOT”, “SHOULD”, “SHOULD NOT”, “RECOMMENDED”, “MAY”, and “OPTIONAL” in this document are to be interpreted as described in [RFC2119].

All sections and appendixes, except “Scope”, “Release Version Overview” and “Conformance Requirements Notation Details”, are normative, unless they are explicitly indicated to be informative.

The formal notation convention used in sections 8 and 9 to formally express the structure and internal dependencies between specifications in the Enabler Release specification baseline is detailed in [SCRRULES].

### 3.2 Definitions

<b>Application Usage</b>	Detailed information on the interaction of an application with an XCAP server. (Source: [RFC4825])
<b>Enabler Release</b>	Collection of specifications that combined together form an enabler for a service area, e.g. a download enabler, a browsing enabler, a messaging enabler, a location enabler, etc. The specifications that are forming an enabler should combined fulfil a number of related market requirements.
<b>Minimum Functionality Description</b>	Description of the guaranteed features and functionality that will be enabled by implementing the minimum mandatory part of the Enabler Release.
<b>Principal</b>	Use definition from [Dict].
<b>XCAP Server</b>	An HTTP server that understands how to follow the naming and validation constraints defined in this specification. (Source: [RFC4825])

## 4. Release Version Overview

### 4.1 Version 1.1 Functionality

The XML Document Management (XDM) enabler defines a common mechanism that makes user-specific service-related information accessible to the service enablers that need it. XDM specifies how such information is represented in well-structured XML documents, as well as the common protocol for access and manipulation (e.g. created, changed, deleted, etc.) of such XML documents.

The XDM Specification [XDM\_Core] defines the features of the XDM enabler, which include the following:

- The common protocol, XML Configuration Access Protocol (XCAP) [RFC4825], by which Principals can store and manipulate their service-related data, stored in the network as XML documents.

Documents accessed and manipulated via XCAP are stored in logical repositories in the network, called XML Document Management Servers (XDMS). Each repository may be associated with a functional entity which uses its data to perform its functions.

Each XML document stored in an XDMS is described as an Application Usage, which enables applications to use the document via XCAP. The XDM enabler describes Application Usages which can be reused by multiple enablers and are stored in logical entities called Shared XDMSs. The documents defined by the XDM V1.1 enabler are as follows:

- URI List and Group Usage List documents stored in the Shared XDMS.

### 4.2 Version 2.0 Functionality

The XDM V2.0 enabler defines new functionality that extends XDM to support the OMA SIMPLE Instant Messaging (IM) V1.0 and Push-to-talk over Cellular (PoC) V2.0 enablers.

To accommodate the needs of these enablers, the following functionality is added in XDM V2.0:

- Search for information in documents stored in an XDMS;
- Network to Network Interface to enable search and retrieval of information across multiple domains; and
- The SIP subscription/notification mechanism by which Principals can be notified of changes to XML documents.

XDM V2.0 inherits the Shared XDMS from XDM V1.0, but renames it as the Shared List XDMS [XDM\_List] to accommodate several new documents that are stored in separate Shared XDMS logical entities:

- Group document stored in the Shared Group XDMS [XDM\_Group];
- User Access Policy document stored in the Shared Policy XDMS [XDM\_Policy]; and
- User Profile document stored in the Shared Profile XDMS [XDM\_Profile].

The Group and User Access Policy document structures are based on those of the PoC Group and PoC User Access Policy documents [PoC\_XDM], respectively. The XDM V2.0 enabler defines how to handle backwards compatibility with the PoC V1.0 enabler when the Shared Group XDMS and Shared Policy XDMS are introduced in the network.

### 4.3 Version 2.1 Functionality

The XDM V2.1 enabler defines new functionality that extends XDM to support the OMA Converged IP Messaging (CPM), OMA Converged Address Book (CAB) and OMA PoC 2.1 (Push to Talk over Cellular) enablers.

To accommodate the needs of this enabler, the following functionality is added in XDM V2.1:



- Access permissions to define which Principals have rights to perform XDM functions to an XML document;
- Document history management in order to capture some (or all) changes applied to an XML document;
- An HTTP POST based protocol, XDCP, enabling additional document operations;
- Subscription to and notification of changes in XDM Documents using XDCP and OMA Push Enabler; and
- User Preferences Profile document stored in an XDMS.
